Rockville Centre Sets the Standard as First Certified Sensory Police Department in New York

The Village of Rockville Centre announced today its Police Department is the first in New York State to become Certified Sensory InclusiveTM by KultureCity, a leading nonprofit organization dedicated to promoting inclusivity and accessibility for individuals with sensory needs. Through its program, KultureCity helps train others to address the one in four individuals diagnosed with an invisible disability, such as autism, PTSD, dementia, ADHD, traumatic brain injury, and strokes to name just a few.

"This vital training enhances the day-to-day interactions with individuals who have sensory needs or invisible disabilities," commented Mayor Francis X. Murray. "Thanks to the partnership with KultureCity, our officers are equipped with the tools to respond with compassion and the necessary skills to make a positive impact."

The certification process entailed officers from the Rockville Centre Police Department be trained by leading medical and neurodivergent professionals on how to recognize community members with sensory needs and how to handle a sensory overload situation. KultureCity's training instills understanding, acceptance, and empathy towards those who have sensory needs with the goal to enhance future interactions between law enforcement and the community to create

"The Rockville Centre Police Department remains one of the most highly trained departments in the state," commented RVCPD Commissioner Randy Dodd. "This training and certification received not only renews our commitment to those we serve but allows our officers to improve the interactions we have with our most vulnerable residents

Lifelong Rockville Centre resident, Sean Culkin, was diagnosed with autism as a child. Now 30, Culkin serves as an ambassador and board member with KultureCity. To bring the sensory inclusion program to the Rockville Centre Police Department, Culkin joined with

Tony and Mary Lou Cancellieri, the founders of RVC Blue Speaks, to meet with Deputy Mayor Kathy Baxley about implementing the program. The nonprofit organization,



dedicated to raising money for families affected by autism, provided funding for the program.

In addition to the invaluable training, each patrol vehicle is equipped with sensory inclusive items to be available to those with sensory needs in an emergency situation. Each sensory bag includes feelings thermometer that includes a range of different emotions and cues intended to help bridge the communication gap in an emergency, fidget tools to help individuals de-stress and calm down during high stress situations, and noise-dampening headphones, which tune out ambient noise, while still

allowing the wearer to communicate to help in

"My husband and I cofounded RVC Blue Speaks to advocate for individuals on the autism spectrum," stated Mary Lou of RVC Blue Speaks. Fall Hydrant Flushing

The Water Department will be conducting routine hydrant flushing beginning Wednesday, October 23rd and ending on Tuesday, October 29th. Hydrant flushing is vital for the general maintenance of the Village's water services and is performed twice a year – once in the spring and once in the fall. It ensures performance of fire hydrants for firefighting purposes, and quality water for residents and businesses.

While the flushing program is underway, customers may experience a slight drop in water pressure or temporary water discoloration. Although this water is perfectly safe to drink, it may stain laundry. Customers should refrain from doing laundry while the flushing program



If tap water is discolored, it is recommended to run coldwater faucets for a short time until the water

is underway.

runs clear. Using more than one faucet allows the water to clear faster.

The schedule will be as follows:

- Wednesday, October 23rd between 8 a.m. and 4 p.m. Area of the Village lying North of DeMott Avenue.
- Thursday, October 24th between 8 a.m. and 4 p.m. Area of the Village lying between Lakeview Avenue and DeMott Avenue, west of Long Beach Road.
- Friday, October 25th between 8 a.m. and 4 p.m. Area of the Village lying between Sunrise Highway and DeMott Avenue, east of Long Beach Road.
- Sunday, October 27th to Monday, October 28th between 12 a.m. to 8 a.m. Entire area of the Village lying between Lakeview Avenue and Merrick Road.
- Tuesday, October 29th between 8 a.m. and 4 p.m. The entire area of the Village south of Merrick Road.

Leaf Pickup

Leaf pickup will begin on Monday, November 18, 2024. Bagged leaves will be collected from the curb strip as follows:

- Monday: North of Sunrise Highway
 (between Hempstead Ave & N. Long Beach Rd)
- Tuesday: North of Sunrise Highway (East of N. Long Beach Rd)
- Thursday: North of Sunrise Highway (West of Hempstead Ave)

• Friday: South of Sunrise Highway

Please note there will be no leaf pickup on Thursday, November 28 and Friday, November 29, 2024. The last day of pickup will be on Friday, December 13, 2024.

Parking Permit Information

November 1st all Employee Parking Permits vill renew.

Holders of an "E" permit will receive a preprinted renewal at their place of employment the last week of September. The renewals should be mailed along with a copy of the vehicle registration and the \$257 payment in the envelope provided.

Holders of a "Q" permit will not receive preprinted renewals and will need to reapply for a quarterly or annual permit. Please refer to the Village website for the appropriate application and the mandatory notarized employer letter.

All Employee Parking Permits will be mailed out in a bulk mailing the last week of October to their employer.

Tax Office Announcements

Real estate tax exemptions are available to volunteer firefighters with certified service and to veterans based on the date and type of military service. The maximum assessed value that may be exempted varies with the status of the veteran claimant: non-combat and Cold War \$518; combat \$864; and disabled up to \$1,728 based on

the percent of disability.

Real estate tax exemptions are also available to disabled homeowners and to senior homeowners 65 and older with a 2023 gross income not exceeding \$58,399.

Applications are available on the Village website www.rvcny.gov on the Tax Office page, by emailing taxoffice@rvcny.us or by calling the Tax Office Monday to Friday from 8 a.m. to 4 p.m. at (516) 678-9242.

The filing deadline for all 2025/26 exemption applications is January 2, 2025.

New property owners and those who have satisfied, refinanced or sold their mortgage to another lending institution should contact the Tax Office as soon as possible either by email at taxoffice@rvcny.us or telephone at (516) 678 9242 in order to avoid billing errors that may lead to penalties for late real estate tax payments.

Clean Up After Your Pet

The Village of Rockville Centre would like to remind pet owners to be a good neighbor and clean up after your dog. In an effort to be courteous, dog walkers should carry disposable waste bags and clean up after their pets. Used dog waste bags should not be left in neighbors' trash cans or recycling bins and should not be thrown into the storm drains on our streets and roadways. Proper disposal of dog waste is required, and every dog owner must participate.

Viewpoint: Comments by Gregory P. Shaughnessy

It has been just over a year since I was elected as your newest Village Trustee. During this time not only have I continued to be exposed to the many great people and organizations in and around our Village, but also many of our dedicated employees and departments.

I have a much better understanding of the Village finances and how it relates to each of our department's budgets and the challenges that come along with having our own municipal services such as water and electric utilities. As the liaison to these important services, I enjoy partnering with our department heads to continuously enhance service and delivery of these vital utilities.

Anyone that knows me, knows I have many passions and yes, golf and youth sports are among them but high on the list is real estate. From zoning and land use to development, redevelopment and historical preservation. These considerations play a pivotal role in

The uniqueness of our Village is something very special that I speak about frequently, from

I am an advocate for evaluating and updating our zoning, codes, and land uses as this is an essential component in the "RVC Forward"

In the ever-changing definition of a "legal" business, as defined by the State and our Federal government, our Village must adapt in order to not have any one use, or new uses

monopolize our Village. Redefining our codes to appropriately allow these businesses to operate under the law is important for moving "RVC Forward." As an example, restaurants or cabarets, as defined under our code as a restaurant with live music, on where and how they can operate. In this example is important to understand we cannot dictate a type of restaurant, but what we can dictate is where a

restaurant can go and how it can operate with or without live music. Another current example is the pressure on our Village and surrounding communities with businesses that may be less desirable. A business like this cannot be allowed to operate in our Village in areas that we deem to have a sensitive use like our schools, places of worship, playgrounds, recreation and community centers to name a few. We continue to work on zoning recommendations in our everchanging world.

Our board also has a renewed focus on code enforcements, not only within our Building Department in our residential and commercial districts, but also within our Police Department in working with the NY State Liquor Authority and the Nassau County Fire Marshal to enforce our codes

Ilook forward to gaining even more knowledge over my term through actively participating in organizations like the New York Conference of Mayors (NYCOM), Nassau County Village Officials Association (NCVOA), New York Association of Public Power (NYAPP) and strategizing how best to move "RVC Forward."

School's Open Drive Carefully

As our children have returned to the classrooms, all motorists are reminded to take extra precautions to keep our youngest commuters safe when they are traveling on our roadways. Schools return means more buses picking up and dropping off students, more people walking and bicycling to and from school, and more congestion which means an increase for potential hazards.

"It is imperative that motorists remain alert and use caution, stop for pedestrians, obey traffic signs, and slow down," commented Mayor Francis X. Murray. "I am begging every driver to stay alert and cut out all of the distractions, including texting and talking on cell phones to ensure everyone, especially our children, make it home safely."

Speed limits around our schools are 20 miles per hour, whether motorists are on a side street or a main road. In addition, all drivers moving in either direction must stop for a stopped school bus, which is picking up or dropping off children. Motorists must remain stopped until all children are clear of the roadway and the bus stop arm is withdrawn. The Village and the schools partnered in September, as they do every year, to provide a bicycle safety course for elementary school students.
